## **INFORMING GUESTS / TOURISTS ABOUT THE COLLECTION AND PROCESSING OF PERSONAL DATA**

On the basis of Regulation (EU) 2016/679 of the European Parliament and the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, notice is hereby given that:

- **Processing shall be lawful only if and to the extent that at least one of the following applies:**

- (a) the data subject has given consent to the processing of his or her personal data for one or more specific purposes;
- (b) processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract;
- (c) processing is necessary for compliance with a legal obligation to which the controller is subject;
- (d) processing is necessary in order to protect the vital interests of the data subject or of another natural person;
- (e) processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller;
- (f) processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child.

Point (f) shall not apply to processing carried out by public authorities in the performance of their tasks.

- **Conditions for consent:**

- ‘consent’ of the data subject means any freely given, specific, informed and unambiguous indication of the data subject's wishes by which he or she, by a statement or by a clear affirmative action, signifies agreement to the processing of personal data relating to him or her.
- Where processing is based on consent, the controller shall be able to demonstrate that the data subject has consented to processing of his or her personal data.

- If the data subject's consent is given in the context of a written declaration which also concerns other matters, the request for consent shall be presented in a manner which is clearly distinguishable from the other matters, in an intelligible and easily accessible form, using clear and plain language. Any part of such a declaration which constitutes an infringement of this Regulation shall not be binding.
- The data subject shall have the right to withdraw his or her consent at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. Prior to giving consent, the data subject shall be informed thereof. It shall be as easy to withdraw as to give consent.
- When assessing whether consent is freely given, utmost account shall be taken of whether, *inter alia*, the performance of a contract, including the provision of a service, is conditional on consent to the processing of personal data that is not necessary for the performance of that contract.

The purpose of this processing is necessary for the exercising of the official authority vested in the controller. Data are collected and processed in accordance with Regulation (EU) 2016/679 of the European Parliament and the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and the Regulation on the manner of keeping a list of tourists and the form and content of the form for the registration of tourists with the tourist board (*Narodne Novine* Official Gazette No. 126/15) (hereinafter referred to as the Regulation). The purpose of the collection and processing of data is to enter the data about the tourist into the e-Visitor system on the basis of the Regulation issued by the Ministry of Tourism of the Republic of Croatia. The types of data that are collected and processed in the e-Visitor system are:

- Surname and first name
- Place, country and birth date
- Citizenship
- Type and number of identity document
- Place of residence (domicile) and address
- Date and time of arrival and departure from the property
- Gender
- Remarks
- Number of registration

The data subject has the right to request access to and rectification or erasure of personal data or restriction of processing concerning the data subject and to object to processing as well as the right to data portability.

Where processing is based on point (a) of Article 6(1) or point (a) of Article 9(2), the existence of the right to withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.
